MINUTES OF THE ANNUAL GENERAL MEETING

held on Monday 27 September 2021 at 3pm virtually on Zoom

The President, Professor Dame Sue Black, Baroness Black of Strome, in the Chair.

1. Minutes of the Annual General Meeting of 16 October 2020

The Minutes were circulated before the meeting. The Minutes were approved.

2. Annual Report of the Council for 2020

The President, Baroness Sue Black, presented the Report of the Council as printed in the Annual Report for 2020. Baroness Black thanked Dr David Shankland and the RAI staff for keeping the institute going through the pandemic. The big event for 2020 was the awarding of the Royal Charter to the Royal Anthropological Institute. In normal times this would have been an occasion for a large celebration, but we have had to put this on hold due to the present circumstances. The Anthropology and Geography conference was a great success and holding it online meant we were able to attract an international audience. We reopened the RAI offices on 1 September and we can now welcome visitors by appointment. Our first in person event will be the Huxley Lectures at the British Museum on 14 December 2021. Since we were unable to hold the event last year this will be a double lecture with the Huxley Lecture for 2020 by Prof Stephen Levinson and the Huxley Lecture for 2021 by Prof Stephen Shennan.

The Hon. Treasurer, Dr Fiona Bowie, reported that despite the difficulties of Covid we have maintained a stable financial status. No RAI staff members were furloughed and all were able continue with their duties remotely. We are preparing for a drop in income because of the changes to publishing models. There has also been a drop in DVD sales and it is important for us to have the film collection available via streaming as well. A Fundraising Committee has been inaugurated and is chaired by Robert McDowall. The RAI has changed to ethical funds for its investments.
