



2012 Annual Report

2012 was a good year, even a very good year. The refurbishment of our main rooms being successfully concluded, we were able to use the full extent of four floors in our building for the first time. The great advantage of this is that we now have distinct spaces for activities for Fellows meetings, collections, film, archive and photo, and administration and, as they all do have their own space, they can all continue simultaneously.

Looking at the highlights of the many different activities which we ran over the year; a fascinating Huxley lecture was given by Professor Alan MacFarlane on "Anthropology, Empire and Modernity" to a packed audience in the British Museum, and the Henry Myers Lecture was given by Professor Ian Hacking on "The Anthropology (and Archaeology) of Numbers". Aiming to increase our activities in the universities, we ran the second 'RAI postgraduate conference' at the University of Kent, and likewise at Kent the first 'RAI undergraduate conference'. This last in particular was an extra-ordinary event, full of papers of the highest quality. It is wonderful that we can attract young persons of this calibre to the field, even in this time of economic austerity, and bodes well for the future.

At the RAI itself, preparations continued for the Film Festival that was to take place at Edinburgh in 2013, whilst at the same time we ran a series of events and films on the theme 'Bodies in Motion'. Photographic events in our new Council room also became a regular and welcome feature, including "Imagi/Nations: Native North American Photographs", and "The Body Canvas Photography Exhibition", which contained some remarkable images. The London Anthropology Day, held in the summer, continued to be as popular as ever. Our flourishing education programme organized a two-day conference on 'Teaching Anthropology' at the University of Oxford that was sold out, and from which we learnt a great deal.

The greatest event of the year, however, was the conference Anthropology in the World, which took place at the British Museum, 8th-10th June. This was a major achievement. It brought together more than four hundred anthropologists from many nations in order to discuss the place and future of anthropology outside the university. The range of panels was wide, including speakers on design anthropology, anthropology and tourism, forensic anthropology, anthropology in government, and so on. More than this, however, there was a spirit, and effervescence of excitement about the possibilities that anthropology can, and does offer, that made it a most worthwhile three days. I should like to thank once more all the speakers, and most particularly our key-note speaker, Dr Gillian Tett, who recorded her address in most professional fashion, when she was prevented at the last minute from joining us in person from New York. We should also thank our principle sponsor for the event, the Wenner-Gren Foundation, whose generosity makes an extra-ordinary contribution to anthropology on a global scale. The programme for this event is still available on the net, via the RAI web-pages.

Our well-known publishing activities continued regularly, and with conspicuous success, including the continuing expansion of readers of the *Journal of the Royal Anthropological Institute*, and the regular publication of *Anthropology Today*. *Anthropological Index Online* flourishes, now with a new publisher.

This year too, saw the first full year of publication of our on-line free journal *Teaching Anthropology*, and the beginnings of a co-operation with Alexander Street in order to create data-bases of our archive and film collections, an initiative that we hope will continue to bear fruit in the coming years.

All these events and activities, which complement our normal round of business, could only be possible with the whole-hearted devotion of our staff. It would be invidious to single out any one person, and I thank them all. Likewise, after two years in my role of President I am profoundly conscious of the worth of our specialist committees, all of whom are supported by volunteers from across the country, and whose work is diverse and renowned. Council presides benignly and with skill over this extra-ordinary community of anthropologists. Together, we have an institute of which we can be truly proud.

Treasurer's Report

The RAI held a steady financial position in 2012, maintaining an overall surplus at the end of the year. Our equities investments showed signs of recovering, and the fund balance at the end of the year remained buoyant. We are again grateful to the generosity of the anonymous donor, and have received further grants from the William Buller Fagg Trust, the Wenner-Gren Foundation, and the ESRC, this last for the Social Sciences festival.

The instability of the financial world situation, and the more specific rise of 'open access' publishing means that the future income of the institute may be affected by a reduction from Wiley, our publishers. We have therefore put into place a programme of diversification of activities and their related income, in order to reduce the reliance of the RAI on any single source of funds. These activities in 2012 include for example a large conference at the British Museum entitled *Anthropology in the World*, joining anthropology data-base publication with the Alexander Street Press, and seeking donation from fellows of any unwanted anthropology books, that may either go to our library, or if already there, disposed of for the benefit of the RAI.

The RAI recommended that the Esperanza fund, which it administers on behalf of its Trustees, diversify their portfolio by spending a proportion (25%) of its holding in acquiring a property, which was successfully achieved in the autumn of 2012.

Income from Fellowship and membership saw a slight increase on the previous year, indicating a promising trend. Provided that we can successfully diversify in the coming years, we can continue to be cautiously optimistic about our financial position.
